How much does a battery storage project cost in Israel?

The Israeli Electricity Authority (IEA) has awarded contracts for 1.5 GW of high-voltage battery storage capacity across 11 projects to be developed in three regions of Israel. The tender, which attracted 11 bidders proposing 29 projects for a total capacity of 4 GW, set capacity tariffs ranging from US\$49.41/kWh to US\$74.20/kWh.

Why are tolling agreements important in battery energy storage?

Tolling agreements are growing in importance in the battery energy storage space, offering a certainty of revenue which in turn improves the prospects of getting debt financing. Under such deals, the offtaker guarantees a fixed payment in return for complete trading control of the battery.

How much does a kW power plant cost?

The tender, which attracted 11 bidders proposing 29 projects, set capacity tariffs ranging from 2.0 to 3.0 agorot per kW, which in USD is approximately \$0.00564 to \$0.00847 per kW. (Note that a conversion is therefore needed to kWh, which is an annual figure. Fully formed, the price is therefore \$49.41 to \$74.20 per kWh.)
